

	The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.		
FORMAT:	All events will be timed finals.		
WARM-UP:	Open warm-ups are scheduled for 1:00 pm to 1:45 pm; competition starts at 2:00 pm		
ENTRIES:	DEADLINE FOR THE RECEIPT OF ENTRIES IS FRIDAY, MAY 22, 2009		
	Entries must be submitted in long course meter times using Hy-Tek Team Manager and Commlink-2 software, or on a VSI master entry sheet		
	• Teams may submit entries as an e-mail attachment (preferred) or on a 3 ½" computer disk.		
	 A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name, e-mail addresses, and phone number of the person to contact in case of questions, regardless of how they are submitted. 		
	 Coaches Times (CT) will be accepted for events in which a swimmer does not have a time of record. CT may not exceed a "B" time. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition. 		
	Swimmers may enter a maximum of one (1) individual event.		
	• Entries will be processed in the order received. Each event will be limited to 4 heats. Date and time of receipt and will be used in the event the total entries exceed the stated limit. We must be out of the pool by 6:00 pm		
	The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session, or to combine events in which there are insufficient entries. This may include combining heats and events, which actions may require reseeding.

SEEDING:	All events will be deck seeded.
	Positive check is required and will close at 1:30 pm
	SWIMMERS FAILING TO POSITIVELY CHECK-IN WILL NOT BE ALLOWED TO SWIM THE EVENT.
	Deck entries will be accepted in the order received to the extent the open lanes are available
	• Events 1, 2, 5 and 6 will be swum two (2) swimmers per lane as needed up to a maximum of 56 swimmers per event. If we do not have 56 entries per event, the fastest seed times will be swum with one (1) swimmer per lane.
	For events 5 and 6, entry preference will be given to swimmers excluded from the TIDE Speedo Spring Challenge on May 1-3, 2009.
PENALTIES:	Penalties for entries using fraudulent and/or non-verifiable entry times:
	Swimmer shall be disqualified from the event entered illegally and the event re-awarded.
	Club may be fined \$100 for each offense, and a record of such offenses shall be kept and published as part of the official meet results.
	Clubs entering swimmers not legally registered with United States Swimming by the first day of the meet may be fined \$100 per swimmer in each event so entered.
	If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.
RULES:	The current USA Swimming Rules and Regulations will apply.
	The overhead start procedure will be used for all sessions.
	In accordance with VSI Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.

Take a right onto Hampton Blvd. Go approximately one mile and turn right onto 90th Street. The pool is visible from Hampton Blvd, but it is about 200 meters from the road.
