Automatic timing by Colorado Systems</li><li>• The competition course has not been certified in accordance with current <i>USA Swimming Rules and Regulations</i>, Article 104.2.2(C).</li></ul>

<b>ELIGIBILITY:</b>	<ul style="list-style-type: none"><li>• Open to all USA Swimming/Virginia Swimming athletes 8 years old and younger from WAC, US, TAC, VYAC, and ODAC registered by the first day of the meet</li><li>• No on deck USA Swimming/Virginia Swimming athlete registration will be permitted.</li><li>• Age on October 10, 2009 will determine age for the entire meet.</li></ul>
<b>DISABILITY SWIMMERS:</b>	<ul style="list-style-type: none"><li>• Athletes with a disability are welcomed and shall provide advance notice of desired accommodations to the Meet Director.</li><li>• The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.</li></ul>
<b>FORMAT:</b>	<ul style="list-style-type: none"><li>• The events are in a pentathlon format.</li><li>• All events will be timed finals.</li><li>• There will be an Ice Cream Sundae Party at the conclusion of the meet.</li></ul>
<b>WARM-UP:</b>	Warm-ups are at 9:00 am; competition starts at 10:00 am
<b>ENTRIES:</b>	<p><b>DEADLINE FOR THE RECEIPT OF ENTRIES IS SUNDAY, OCTOBER 5, 2009</b></p> <ul style="list-style-type: none"><li>• Entries must be submitted in short course yard times using Hy-Tek Team Manager and Commlink-2 software, or on a VSI master entry sheet.</li><li>• Teams submit entries as an e-mail attachment</li><li>• A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted</li><li>• Coach's Times (CT) will be accepted for events in which a swimmer does not have a time of record. CT may not exceed a "B" time. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition.</li><li>• "No Time" (NT) entries will not be accepted.</li><li>• Swimmers may enter a maximum of 5 <i>individual events</i> per day.</li><li>• The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. <b>FEES:</b>	Individual events: \$3.00 Swimmer surcharge: \$2.50 per person (entered in the meet in any capacity) <ul style="list-style-type: none"><li>• Checks should be made payable to: <b>ODAC Meets</b></li></ul>

	<ul style="list-style-type: none"> <li>• Payment must be received by October 10, 2009 for email entries. Payment must be included with all mailed entries</li> <li>• Failure to pay entry fees by this deadline could result in teams being barred from the meet.</li> </ul>
<b>AWARDS:</b>	<ul style="list-style-type: none"> <li>• Individual events: Ribbons will be awarded for first through sixth place in each event</li> <li>• Bobble Head Trophies will be awarded for first through eighth each age group in the overall final standings.</li> <li>• Awards will be given for each age group: 6 and under, 7 year olds and 8 year olds.</li> </ul>
<b>SEEDING:</b>	<ul style="list-style-type: none"> <li>• All events will be pre-seeded.</li> <li>• Swimmers should report directly to the blocks for their events.</li> <li>• Deck entries will be accepted in the order received for swimmers already entered in the meet, to the extent that open lanes are available. No additional heats will be added. Deck entries must be submitted to the Clerk-of-Course on the provided forms.</li> </ul>
<b>PENALTIES:</b>	<p>Penalties for entries using fraudulent and/or non-verifiable entry times:</p> <ul style="list-style-type: none"> <li>• <b>Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded.</b></li> <li>• <b>Club may be fined \$100 for each offense, and a record of such offenses shall be kept and published as part of the official meet results.</b></li> <li>• <b>Clubs entering swimmers not legally registered with United States Swimming at least 24 hours prior to the start of the meet may be fined \$100 per swimmer in each event so entered.</b></li> <li>• If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.</li> </ul>
<b>RULES:</b>	<ul style="list-style-type: none"> <li>• The current USA Swimming Rules and Regulations will apply.</li> <li>• The overhead start procedure will not be used.</li> <li>• In accordance with VSI Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet and will be required to leave the deck area.</li> </ul>

<b>SAFETY:</b>	Virginia Swimming Meet Safety Procedures will be in effect.
<b>GENERAL:</b>	<ul style="list-style-type: none"> <li>• <b>NO SMOKING</b> on the pool deck or in the spectator gallery.</li> <li>• Each Team is encouraged to ensure the good conduct of swimmers in all areas of the building, including but not limited to locker rooms and hallways.</li> <li>• <b>NO GLASS</b> containers are permitted in or around the pool area.</li> </ul>
