| ELIGIBILITY: | - Open to all USA Swimming/Virginia Swimming athletes registered by the first day of the meet <br> - No on deck USA Swimming/Virginia Swimming athlete registration will be permitted. <br> - Age on October 31, 2009 will determine age for the entire meet. |
| DISABILITY SWIMMERS: | - Athletes with a disability are welcomed and shall provide advance notice of desired accommodations to the Meet Director. <br> - The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition. |
| FORMAT: | - All swimmers will swim in a single session on both Saturday and Sunday <br> - All events will be timed finals. |

| ENTRIES: | DEADLINE FOR THE RECEIPT OF ENTRIES IS THURSDAY, OCTOBER 22, 2009 <br> - Entries must be submitted in Short Course Yard times using Hy-Tek Team Manager and Commlink-2 software, or on a VSI master entry sheet. <br> - Teams submit entries as an e-mail attachment <br> - A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted. <br> - Coach's Times (CT) and "No Time" (NT) entries will be accepted for events in which a swimmer does not have a time of record. CT may not exceed a "B" time. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition. <br> - Swimmers may enter a maximum of 4 individual events and 1 relay event per day. <br> - Relay teams must be designated A, B, C, etc., if more than one per club is entered per event. <br> - Entries will be processed in the order received. An e-mail will be sent confirming receipt of the teams' entries. <br> - The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. | AWARDS: | - Individual events: Ribbons will be awarded for first through eighth place. <br> o 10 \& Under individual events will be given separate awards for 9-10 and 8 \& Under age groups <br> o 12 \& Under individual events will be given separate awards for 11-12, 9-10, and 8 \& Under age groups <br> o 13 \& over individual events will be divided into $13-14$ and 15 \& over age groups. <br> - Relay events: Ribbons will be awarded for first through eighth place. <br> - All Swimmers entered in this meet will receive a Halloween Swim Cap as part of our Theme Meet |
| SEEDING: | - All events will be pre-seeded. Swimmers should report directly to the blocks for their events. <br> - Events \#47-48 (13\&O 500 Free), 63-64 (13\&O 1000 Free), 89-90 (12\&U 500 Free), and 117-118 (13\&O 1650 Free). will require a positive check-in to swim and will be reseeded if heats are eliminated. <br> - Positive check-in will close at the end of warm-ups for the session in which the event is scheduled except for the distance sessions. <br> - Distance Session positive check-in will close at 9:30 am <br> - SWIMMERS FAILING TO POSITIVELY CHECK-IN WILL NOT BE ALLOWED TO SWIM THE EVENT. <br> - Deck entries will be accepted in the order received for swimmers already entered in the meet, to the extent that open lanes are available. | PENALTIES: | Penalties for entries using fraudulent and/or non-verifiable entry times: <br> - Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded. <br> - Club may be fined $\mathbf{\$ 1 0 0}$ for each offense, and a record of such offenses shall be kept and published as part of the official meet results. <br> - Clubs entering swimmers not legally registered with United States Swimming by the first day of the meet may be fined $\mathbf{\$ 1 0 0}$ per swimmer in each event so entered. <br> - If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer. |
| RULES: | - The current USA Swimming Rules and Regulations will apply. <br> - The overhead start procedure will be used for the afternoon sessions, and may be used for the morning sessions at the discretion of the Referee. <br> - In accordance with VSI Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area. |

| GENERAL: | - Officials and coaches hospitality will be available <br> - Meet programs will be sold |
| FACILITY RULES: | PLEASE CONVEY THIS INFORMATION TO YOUR SWIMMERS AND PARENTS: <br> - Picture identification will be required to gain access to the base. <br> - Rules will be enforced by meet marshal, aquatic center staff and the Fort Eustis Fire Marshall. <br> - Swimmer/Spectator Conduct: Each club is responsible for supervising the conduct of its swimmers/spectators. Any swimmer/spectator that violates Aquatic Center rules, posted at the pool and/or in the meet program, will be disqualified form the meet and escorted from the facility. <br> - The Aquatic Center prohibits food of any kind in the pool area.
