- **Warm-up procedures:** Review Thursday in particular. Questions and/or problems?
- **Heat sheets:**
 - Thursday evening will be out after seeding
 - Available at the start of warm-ups for each session
- **Swimming everything in one pool 50 start on dive end. Review process**
- **Time lines:** Estimates for other sessions are in the coaches packets and will be posted when we know them.
- **Deadlines:** Please observe
- **Deck procedures**
 - Dive over starts will be used for prelims

- CJ will talk to the swimmer; DQs will go to the swimmer's coach
- Questions about DQs should first be directed to the deck referee. Come to me if issue cannot be resolved
- **Administrative procedures**
 - Must clear POT prior to seeding to be seeded and all fees must be paid
 - Late entries accepted as long as scratch box is open for the event
 - See Admin Referee - Terry Randolph
 - Time trials
 - Deadline to sign-up is 10:30 am each day unless a later time is announced. Mary Ferrari at Clerk of Course.
 - Count against the three event per day limit, not meet limit
 - \$15 in cash/check – we're very flexible on refunds
 - Run at the conclusion of trials
 - Any issues of swimmer eligibility should first be dealt with by the Administrative Referee; if the issue cannot be resolved at that level, then I will get involved
 - REVIEW SCRATCH PROCEDURE SHEET FOR COACHES
- **Relays**
 - Friday
 - Trials end: 800 Free Relay – Fastest 2 heats in finals
 - Saturday
 - Trials end: 400 Medley Relay – Fastest 2 heats in finals
 - Sunday
 - Trials end: 400 Free Relay – Fastest 2 heats in finals
- **800 M Freestyle**
 - Fastest heat swimming in finals
- **Finals session**
 - Order being swum: bonus>consols>finals
 - Swimmers in consols and bonus consols should report directly behind the blocks
 - Swimmers in finals will be announced while behind the blocks. Their bios will be read, if provided to the announcer.
 - Alternates should report to the starter prior to their event being called to the blocks.

- No alternate will be called until the heat has been called, stepped up, closed, and then stepped down
- **Sportsmanship**
 - If not returning for finals, please scratch—especially on Sunday, and scratch deep. Remember some swims can be in prelims
- **Safety**
 - VSI Warm-up and Safety Procedures are in effect (no diving during general)
 - No shaving and no glass on deck
- **Facility rules**
 - Rules are in your packets and have been posted
 - Sauna, warm-water pools, and work-out areas/equipment are strictly off-limits
 - Please make your athletes aware of them
