Virginia Swimming House of Delegates April 30, 2017

Year-round Athletes: 6600 Seasonal: 57 Non-athletes: 922 Clubs: 47

Membership Cards: With the increasing use of Deck Pass and related legislation that was passed last year requiring LSCs to accept it as a valid verification of membership for non-athletes, USA Swimming will no longer be providing membership cards. However, LSCs can order cards from the same vendor at the same price paid by USA Swimming in the past. \$7.50 per 30 cards. Last year I ordered 200 non- coach cards for members registered as 'Other' and 725 coach cards. The cost to VSI for these cards for 2018 would be \$240 plus shipping. It costs approximately \$.56 to mail each card (postage plus lamination) and I estimate annual costs for this is \$500.

Action Item: Decide if VSI wants to continue providing non-athlete membership cards to coach members and those registering as 'Other'.

Contributions: Contributions have been made to the Alzheimer's Association and to the USA Swimming Foundation in memory of Bill Randolph.

Awards Celebration Update:

2017 Numbers

Compared to last year the total number of athletes attending year was almost the same but the number of others attending decreased significantly (479 last year). The number of those purchasing Park Only tickets decreased from 56 last year. Every athlete paid \$8 to attend the picnic this year but with VSI covering the additional \$10.52 for the cost of the lunch. We based our budget for the athlete lunches on 400 attending.

All Star Team: In September it was announced that the criteria for the All-Star Team was changed. The current definition is that athletes who rank in the top 5 of their age group in any event will be named to the team with a team being selected for Long Course as well as Short Course. The dates used for selecting the LC team were 3/1/16 - 7/24/16 while those for the SC team were 9/1/16 - 3/12/17. The 'top time' method of selecting the team was much less complex than that used previously. There were 229 different athletes named to the LC team with 223 named to the SC team. There were 315 different athletes named as All-Stars.

Background Checks: USA Swimming has changed vendors for BG checks. The former vendor's service and quality had diminished during the most recent years of the contract and so the change was made. However, because of the change, any BG check conducted through the new vendor will cost \$38 whether it is an initial screening or the renewal of a previous one. Subsequent renewals with this vendor will cost \$18. While I hope that BG checks with this new company will be finalized in a more timely manner, I do not know if that will be the case. Please do not wait until the last minute to initiate a renewal! With the previous vendor, Virginia was the slowest state in returning results. I believe this is a state issue and not related to the vendor but I am not certain.

Safe Sport: A change was approved to the Recommended Guidelines for as far as chaperones sharing a room with 12 and under athletes. The purpose of this change is to clarify that while USA Swimming does permit a non-coach, non-familial, non-athlete member adult to share a room with athletes under the age of 12 for purposes of safety and appropriate adult supervision, the recommended arrangement is for the adult to share a room with more than one athlete.

Changes to Membership Categories: At its meeting last weekend, the USA Swimming Board of Directors approved the following additions:

- Jr Coach Proposal: this will allow teams to have 16 or 17 year olds serve in a coaching capacity while under the
 direct supervision of a fully certified coach. The individual must meet all membership requirements except the
 BG check. Once the individual turns 18, s/he must pass the BG check. It is strong recommended that teams still
 conduct pre-employment screening for the Jr Coaches (ex. Contact school officials, etc).
- Athletes who are coaches (and vice versa) will no longer be required to pay a fee for each membership category but will be required to submit a registration for each.
- Flex Membership Category: year-round membership category where athletes can participate in a maximum of two meets per year below the LSC championship level.

Swimposium 2017: This year's event will be held on September 30th at the Hilton Garden Inn (Innsbrook) in Richmond. Presenters for the Officials' workshop and the Coaches' workshop have already been secured as well as the Olympian for the Athletes' clinic. Arrangements have been made for the coach certification clinic as well. Both clinics will be held at CSAC.

VSI Disability Committee Report April 27, 2017 Updates on some of our VSI swimmers with a handicap are below:

- Samantha Tubbs has been been training full time in the Olympic Training Course at Colorado
 Springs. Samantha has joined as a member of the USA Resident Team.
- 2. **Joseph Peppersack** is teaching swim lessons for children and for adults. He is planning to be trained as a lifeguard. In May Joseph will compete in the ParaSwimming Meet in Cincinatti, and he will enroll for the ParaSwimming world series meet in Indianapolis. Joseph also graduates this spring, and in the Fall he will be attending the University of Mary Washington, where he will swim on the Official U.M. W. Swim Team.
- 3. **Sean Harrington** still swims. He plans and swims his own sets at the YMCA Aquatic Center in Great Bridge, in Chesapeake. He is no longer swimming competitively. Sean still works part-time at the Chesapeake Regional Medical Center in the Materials Management Dept.
- 4. **Emilia Scovel** is taking two months off from swimming as she recuperates from major surgery, involving muscle lengthening and left ankle manipulation. In late May Emilia will begin swimming again with her summer swim team, the Dominion Valley Sharks.

There are several other swimmers in VSI who may have neurological and/or cognitive disorders; and VSI coaches, officials, and other athlete youth swimmers have been most supportive of these athletes as they push the limits each day as their coach works with them; increasing their endurance, speed, and efficiency in the water.

Representatives from 7 LSCs in the Eastern Zone attended the **Eastern Zone Disability Swimming Clinic** in March. The Facilitator, Mark Rieniets , provided several invigorating lectures and shared an overview of USA Swimming's challenge to "Educate, Empower, and Engage" more disabled swimmers, parents, coaches, and officials to support programs geared for identifying those swimmers with physical or cognitive impairments, optimizing their individual swimming training needs , and providing meets where they can validate their improved performance. Mark is the Chair of the USA Swimming Disability Committee . The three "Ë"s will be one of the main strategies to increase awareness for and start programs for such swimmers in the USA.

Mark noted that there is an estimate of between 3,000 - 7.000 disabled swimmers in the USA. The number of swimmers actually swimming with "impaired" (physical or cognitive limitations) in the USA is far less than expected. There is a growing interest, worldwide, in Paralympic sports.

Mark conducted the Paralympic Officials Clinic from 8 am to 1200 noon. He reviewed the classification schema, both for starting adaptations and for stroke adaptations, based on their coding. Mark discussed the strategy for tapping blind swimmers, hearing enhancements, access of assistants on deck for the starts, and he explained each of the physical codes for "impaired swimmers."

New Jersey swimming, courtesy of LSC, hosted the afternoon swim meet at Rutgers University

pool. The other host was Children's Specialized Hospital. Age range of athletes was 8 to 33 years. One of the athletes, Robert Griswold, had previously competed in the Paralympics, in Rio, De Janiero, in Sept, 2016.

The meet was from 1 pm to 4:30 pm. The Natatorium was the Sonny Werblin Rutgers University Aquatic Center. At the conclusion of the meet , Mark Rieniets and Doug Griswold met with our official trainee group and summarized the coding system and key officiating strategies for open Paralympic

swimming events. Doug also shared with our group other USA clinic dates and Paralympic regional and national meets

Doug and Mark also talked about:

- 1. Ways to support parents of disability swimmers while not letting them get in the way of the coach's planned training.
- 2. How to set up deck (officials, Staging area for swimmers, wheelchair traffic, mats, etc...)
- 3. Ways to demonstrate respect for each of the impaired swimmers on the deck

Doug and Mark provided each of the training officials with a "sample" World Paralympic DQ slip, the key for "Codes of Exception," and the text /outline for the USA Paralympics "Technical Officials briefing." Each of the participants at this clinic fulfilled all the Part I didactic clinical exposure, and they received link from Doug Griswold, to enable them to register as a Level I 8Paralympic Official, for Stroke / Turn judging.



- 1. Two Female Head Coaches were sent to the Women's leadership conference in Colorado, they will give a report to the coaches, BOD and at the HOD on Sunday.
- 2. Six Virginia swimmers, our Diversity committee Athlete's rep and the Diversity Liaison, will attend the 2017 Eastern Zone Diversity Camp and summit, in Buffalo, NY. The camp and summit will be held on the campus of the University of Buffalo.
- 3. I attended the Diversity in Aquatics Conference (DIA) in Miami, FL. The first speaker was the Key note address by the superintendent of schools for the City of Miami, who spoke about bringing learn to swim programs to the city schools in Miami, a city surrounded by water but the majority of its students can't swim, and most of them has never been to the beach.
- 4. A round table discussion of fourteen youth organizations led by the Red Cross National office for Diversity and Inclusion Division, topics included, Getting more Diverse individuals certified in WSI,WSIT, Life Guarding, LGIT. Putting programs into facilities that have none, starting and maintaining Learn to swim programs in Diverse Areas.
- 5. DIA is working to establish programs in HBCU, (Historically Black Universities and Colleges) Coppin State University in Maryland is starting a College swim team.
- 6. Learn to swim programs are the feeder system for all competitive teams, work with those LTS programs to keep the kids in the water and have them make a safe transition to the competitive teams.
- 7. Reach 1 million kids on International Water Safety Day.
- 8. International Water Safety Day, celebrated on May 15th each year, is designed to help spread global awareness of the ongoing drowning pandemic, and to educate youth in becoming safer in and around water.
- 9. In this age of on line sign ups what can we do to get teams to have their parents check the box on the USA registration? Virginia swimming is way behind other LSC in getting this done. 10. An LSC Diversity Camp will be held in April 2018 TBA. This will be a trial run to us hosting the EZ Diversity camp in 2019.
