<b>FACILITY:</b>	<ul style="list-style-type: none"><li>8-lane, 25-yard pool, 4 feet deep in the shallow end sloping to 9 feet in the start side deep end with Kiefer Wave eater lanes, Colorado Timing System</li><li>The competition course has not been certified in accordance with current <i>USA Swimming Rules and Regulations</i>, Article 104.2.2C (4).</li></ul>

<b>ELIGIBILITY:</b>	<ul style="list-style-type: none"><li>Open to all Virginia Swimming registered athletes 8 years old and younger prior to the first day of the meet in the Southwest District which includes (ACAC, BASS, CAST, CCA, CYAC, DYST, FUAC, GATR, HOKI, KFY, LASO, LY, SCAT, SFY, SMAC, STRM, VOLT, and YMST)</li><li>No on deck Virginia Swimming athlete registration will be permitted.</li><li>The qualifying period for this meet is January 1, 2019 through February 7, 2020.</li><li><b>Athletes may compete in any event offered regardless of classification.</b></li><li>Age on February 8, 2020 will determine age for the entire meet.</li></ul>
<b>DISABILITY SWIMMERS:</b>	<ul style="list-style-type: none"><li>Athletes with a disability are welcome and shall provide advance notice of desired accommodations to the Meet Director.</li><li>The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.</li></ul>
<b>FORMAT:</b>	<ul style="list-style-type: none"><li>All events will be timed finals.</li><li>There will be a 5 minute break after relays and before individual events in each session.</li></ul>
<b>ENTRIES:</b>	<p><b>DEADLINE FOR THE RECEIPT OF ENTRIES IS FRIDAY, JANUARY 31, 2020.</b></p> <ul style="list-style-type: none"><li>Entries must be submitted in Short Course Yards times using Hy-Tek Team Manager and Commlink-2 software.</li><li>Teams submit entries via e-mail.</li><li>A <b>Team Manager</b> printout of entries must be included or the VSI meet summary sheet (available at VSI website, <a href="http://www.virginiawswimming.org">www.virginiawswimming.org</a> ) with the name, email address, and phone number of the person to contact in case of questions must accompany the entries, regardless of how they are submitted.</li><li>"No Time" (NT) entries will be accepted for individual and relay events. Coach Times (CT) are <b>not allowed</b> for any event. All entry times must have been achieved in a sanctioned, approved, or observed meet.</li><li>If a relay seed time cannot be created using the times of 4 swimmers entered in the meet, enter the relay with a NT.</li><li>Swimmers may enter a maximum of 8 individual events for the meet, no more than 4 per day and 1 relay event per day.</li><li>Relay teams must be designated A, B, C, etc., if more than one per club is entered per event.</li><li>Entries will be processed in the order received.</li><li>The Meet Director reserves the right to combine heats and events, which may require reseeding.</li><li>Email entries to: <a href="mailto:aserir@ccamarlins.com">aserir@ccamarlins.com</a></li></ul>

	<ul style="list-style-type: none"> <li>Late entries will be accepted. If received prior to the printing of the heat sheet, the swimmer will be seeded into the event; if after, he/she will go in the slowest heat in an empty lane. If needed, a heat will be added.</li> </ul>
<b>FEES:</b>	<p><b>Individual Events: \$4.50</b>  <b>Relay Events: \$15.00</b>  <b>Swimmer Fee: \$2.50 per person (entered in the meet in any capacity)</b></p> <p><b>Late Fees:</b> In addition to the regular entry fee, a fee of <b>\$10</b> per event prior to the first day of the meet and <b>\$25</b> per event on or after the first day of the meet will be charged for any entry received after the entry deadline.</p> <ul style="list-style-type: none"> <li>Checks should be made payable to: CCA Marlins</li> <li>Mail payment to: Attn: Amina Serir 4254 Colonial Avenue, Roanoke, VA 24018</li> <li>Payment must be received by Tuesday, February 4, 2020 for all entries. Failure to pay entry fees by this deadline will result in teams being barred from the meet. Swimmers will be permitted to enter the meet as unattached providing they pay the appropriate entry fees.</li> <li><b>IMPORTANT:</b> If payment is sent via Express Mail/FedEx/Airborne/UPS/etc., please ensure that a signature is NOT required for delivery.</li> </ul>
<b>SEEDING:</b>	<ul style="list-style-type: none"> <li>All events will be pre-seeded.</li> <li>All swimmers should report directly to the blocks.</li> </ul>
<b>WARM-UP:</b>	<ul style="list-style-type: none"> <li>Warm-ups start 1:30 pm; Competition starts 2:30 pm.</li> <li>Lane assignments and warm-up times for individual clubs will be posted on the <a href="#">Marlins website</a> no later than Tuesday, February 5, 2019 and will also be emailed to the contact person of the participating clubs.</li> </ul>
<b>AWARDS:</b>	<ul style="list-style-type: none"> <li>Individual events will be scored and awarded medals for first through third place, and ribbons fourth through sixteenth place.</li> <li>Relay events will be awarded medals for first through third place and ribbons for fourth through eighth place.</li> <li>Team Awards will be given. Total team points will be combined with scores from 9 - 12 District Championships. Teams placing first through third will receive a plaque.</li> <li>Scoring will be as follows: <ul style="list-style-type: none"> <li>Individual: 20-17-16-15-14-13-12-11 - 9-7-6-5-4-3-2-1</li> <li>Relays: 40-34-32-30-28-26-24-22-18-14-12-10-8-6-4-2</li> <li>All events will be scored to 16 places</li> <li>Only the top two relay entries per team may score.</li> </ul> </li> </ul>
<b>PENALTIES:</b>	<ul style="list-style-type: none"> <li>A fine of up to \$100 per event may be assessed for any illegal participation in the meet. Illegal participation is defined as <ul style="list-style-type: none"> <li>Entries using fraudulent or non-verifiable times.</li> <li>Athlete competed in the incorrect age group.</li> <li>Athlete is not registered with USA Swimming prior to the first day of the meet.</li> </ul> </li> <li>If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.</li> <li>Any event in which an athlete participated illegally will be rescored and re-awarded.</li> </ul>
<b>RULES:</b>	<ul style="list-style-type: none"> <li>The current USA Swimming Rules and Regulations, including the Minor Athlete Abuse Protection Policy, will govern this meet.</li> <li>All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (MAAPP) and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.</li> <li>Any swimmer entered in the meet must be certified by a USAS member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer's legal guardian to ensure compliance with this requirement.</li> </ul>

	<ul style="list-style-type: none"> <li>• Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) anytime athletes, coaches, officials and/or spectators are present without written USA Swimming approval.</li> <li>• Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is <u>not permitted</u>.</li> <li>• Changing, in whole or in part, into or out of swimsuit when wearing just one suit in an area other than in a locker room, bathroom, or other space designated for changing is PROHIBITED.</li> <li>• Any athlete suspected of sustaining a concussion or exhibiting signs of a concussion, will immediately be removed from competition and shall not return to competition that day. The athlete may return to competition on a subsequent day, but only with a release authorization signed by a licensed healthcare provider.</li> <li>• In accordance with VSI best practices, swimmers should shower before entering the pool.</li> <li>• In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches with expired or non-current credentials will be required to leave the deck area.</li> </ul>
<b>OFFICIALS:</b>	<p><b>Meet Referee: Name Susan Munson</b>  <b>Email: susamun@cox.net</b>  <b>Phone: (540) 314 5723</b></p> <ul style="list-style-type: none"> <li>• Officials will be needed for all positions and all sessions for this meet.</li> <li>• Training for Officials will be offered in accordance with Training Guidelines and Initial Certification, Virginia Swimming Officials Handbook</li> <li>• Team officials chair should submit the names and session availability of certified officials, as well as the names and session availability of trainees to Douglas Mc Laughlin at dmclaughlin628@yahoo.com no later than Tuesday, February 12, 2020.</li> <li>• Officials meetings will be held in the hospitality area one hour prior to the start of the meet.</li> <li>• General meeting for coaches and key officials will be held in the hospitality area 30 minutes prior to the start of the meet.</li> </ul>
<b>SAFETY:</b>	Virginia Swimming Meet Safety Procedures will be in effect.
<b>TIMERS:</b>	<ul style="list-style-type: none"> <li>• Clubs will be required to provide timers in proportion to the number of swimmers they have entered in each session.</li> <li>• The number of timers required per club and their lane assignments will be posted on the <a href="#">Marlins website</a> no later than Tuesday, February 5, 2019, and will also be emailed to the contact person of each of the individual clubs.</li> <li>• These assignments will also be posted throughout the venue.</li> </ul>
<b>GENERAL:</b>	<ul style="list-style-type: none"> <li>• Meet will be held at the Salem Family YMCA pool, there will be available seating on the pool deck, we will also be using the gym for parents and swimmers while waiting for their events.</li> </ul>
<b>PARKING:</b>	<ul style="list-style-type: none"> <li>• There is one big parking right in front of the YMCA building.</li> </ul>
