	• The qualifying period for this meet is January 1, 2014 through July 9, 2015.			
	No on deck Virginia Swimming athlete registration will be permitted.			
	 8 and younger swimmers may compete in any 8 and under event regardless of their time. 8 and younger swimmers may compete in any 10 and under event in which they have a time that is slower than the age group championship qualifying time. 			
	 14 and younger swimmers may compete in any event in which they have a time that is slower than the age group championship qualifying time. 			
	• 15 and older swimmers may compete in any event in which they have a time that is slower than the senior championship qualifying time.			
	Age on July 10, 2015 will determine age for the entire meet.			
	• 10 & 12 year old swimmers aging up from July 10 to July 23, 2015, and 14 year old swimmers aging up from July 10 to July 16, 2015, with times too fast to qualify for this championship will be allowed to compete under the following conditions:			
	 Any 10 or 12 year old swimmer who does not qualify in their new age group at Age Group Champs may enter the event. 			
	 Any 14 year swimmer who does not qualify for Senior Champs may enter the event 			
	 10, 12, & 14 year old swimmers aging up between championships will be seeded correctly by time, however will swim exhibition only, and will not be eligible to receive an award. 			
DISABILITY SWIMMERS:	Athletes with a disability are welcomed and shall provide advance notice of desired accommodations to the Meet Director.			
	• The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.

WARM-UP:	Morning sessions: Warm-ups at; competition starts at		
	Afternoon sessions: Warm-ups not before; competition starts not before;		
	 Distance session (800 Free): The pool will be opened for 15 min. of open warm-ups immediately following the finish of the afternoon session with competition starting 5 min. thereafter. 		
	 The approximate start time for the distance sessions will be posted on the website, no later than Tuesday, July 7, 2015, and will also be emailed to the contact person of the participating clubs. 		
	 The distance session will start no earlier than the estimated times. 		
	• Lane assignment and warm-up times for individual clubs will be posted on the website, no later than Tuesday, July 7, 2015 and will also be emailed to the contact person of the participating clubs.		
	• If the morning session runs late, afternoon warm-ups will begin immediately after the morning session ends.		
ENTRIES:	DEADLINE FOR THE RECEIPT OF ENTRIES IS TUESDAY, JUNE 30, 2015.		
	Conforming and Non Conforming times will be used for entry – Long Course Meters then Short Course Meters then Short Course Yards using Hy-Tek Team Manager and Commlink-2 software, or on a VSI master entry sheet.		
	Teams submit entries via e-mail.		
	• A Team Manager printout of entries must be included or the VSI meet summary sheet (available at VSI website, <u>www.virginiaswimming.org</u>) with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted.		
	• Swimmer may enter a maximum of 9 individual events, no more than 3 per day.		
	"No Time" (NT) entries will be accepted.		
	The Meet Director reserves the right to combine heats and events, which actions may require reseeding.		
	 Proof of Entry time, if requested, must be provided to the Age Group Chair within two (2) weeks of the request. Times not satisfactorily proved in that length of time will be considered non-verifiable and a fine will be assessed. Email entries to: 		
	 Email entries to: (name and email address) Late entries will be accepted. All late entries must submit proof of time. If received prior to 		
	the printing of the heat sheet, the swimmer will be seeded into the event; if after, he/she will go in the slowest heat in an empty lane. If needed, a heat will be added.

	Late Fees: In addition to the regular entry fee, a fee of \$10 per event prior to the first day of the meet and \$25 per event on or after the first day of the meet will be charged for any entry received after the entry deadline.

AWARDS:	 Individual events will be scored and awarded medals 1st through 3rd place and ribbons 4th through 16th place. 		
	• 13 & over events will be awarded as 13-14 and 15 & over.		
SEEDING:	 13 & over events will be awarded as 13-14 and 15 & over. All events, except the 400 and 800 freestyles, and the 400 IM's will be pre-seeded. 		

	Positive check-in will close at Friday, for event #17-18.			
	Positive check-in will close at Friday, for event #25-26.			
	Positive check-in will close at Saturday, for event #47-48.			
	Positive check-in will close at Saturday, for event #57-58.			
	Positive check-in will close at Sunday, for events #87-88.			
	SWIMMERS FAILING TO POSITIVELY CHECK-IN WILL NOT BE ALLOWED TO SWIM THE EVENT.			
	 Events 87 & 88 (800 Freestyle) will be swum fastest to slowest and alternating heats of girls and boys. 			
PENALTIES:	Penalties for entries using fraudulent and/or non-verifiable entry times:			
	• Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded.			
	• Club may be fined \$100 for each offense, and a record of such offenses shall be kept and published as part of the official meet results.			
	• Clubs entering swimmers not legally registered with USA Swimming before the first day of the meet may be fined \$100 per swimmer in each event so entered.			
	 If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer. 			
	• A \$50 fine will be levied against any swimmer who positively checks-in and declares their intent to swim for a distance event and does not show up to compete.			
RULES:	The current USA Swimming Rules and Regulations will apply.			
	• Any swimmer entered in the meet must be dive certified by a USAS member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.			
	 The overhead start procedure will be used for the sessions, and may be used for the sessions at the discretion of the Referee. 			
	 Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is not permitted. 			
	Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.			
	 In accordance with VSI Best Practices, swimmers should shower before entering the pool. 			
	In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet			
	 Coaches who have valid USA Swimming credentials but who are unable to provide them upon request will be issued temporary credentials by the meet director 			
	• Coaches with expired or non-current credentials will be required to leave the deck area.

	• Team Officials Chairpersons should submit the names and session availability of certified officials, as well as the names and session availability of trainees to: (name, phone, & email) no later than Tuesday, July 7, 2015.

SAFETY:	VSI Safety and Warm-up procedures will be in effect.			
TIMERS:	 Clubs will be required to provide timers in proportion to the number of swimmers they have entered in each session. 			
	 The number of timers required per club and their lane assignments will be posted on the website, no later than Tuesday, July 7, 2015, and will also be emailed to the contact person of each of the individual clubs.
