All chaperones must fill out a Virginia Swimming Staff Honor Code and are bound by USA and VSI Swimming Rules, Regulations and Policies. Virginia Swimming Zone Team Staff Honor Code

As a staff member of Virginia Swimming's 2019 Eastern Zone Long Course Championship Swim Meet. I understand and will comply with the following guidelines and policies as set forth by Virginia Swimming at all times during the meet.

The possession or use of alcohol, tobacco products, including vaping or controlled substances by any staff member participating in the meet is prohibited throughout the duration of the trip (until the team has officially disbanded).
