For individuals who are not members the fee is \$167.00 and the USA Swimming membership is included. This fee does not include the required USA Swimming Background Screening cost. All chaperones must fill out a Virginia Swimming Staff Honor Code and are bound by USA and VSI Swimming Rules, Regulations and Policies. Virginia Swimming Zone Team Staff Honor Code

As a staff member of Virginia Swimming's 2019 Eastern Zone Long Course Championship Swim Meet. I understand and will comply with the following guidelines and policies as set forth by Virginia Swimming at all times during the meet.
